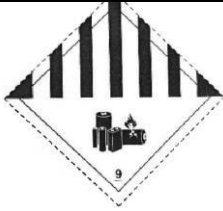

4.急救措施 First aid measures			
眼睛： 万一接触，立即用大量的清水冲洗至少 15 分钟，翻起上下眼睑，直到化学的残留物消失为止，迅速就医。 Eye Flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid. 皮肤： 万一接触，用大量水冲洗至少 15 分钟，同时除去污染的衣物和鞋子，迅速就医。 Skin Remove contaminated clothes and rinse skin with plenty of water or shower for 15 minutes. Get medical aid. 吸入： 立即从暴露处移至空气清新处，如果呼吸困难给予输氧，立即就医。 Inhalation Remove from exposure and move to fresh air immediately. Use oxygen if available. 食入： 饮用两杯牛奶或水。如果当事人仍然清晰可以采取催吐的方法，并且立即就医。 Ingestion

6. 泄露应急处理 Accidental release measures

为防止电池材料泄露或释放采取的措施

如果电池内部材料泄露，试验人员应立即撤离试验区直到烟气消散。将通风设备打开吹散危险性气体。用抹布擦净试验区，清除溢出的液体，将泄露电池放进塑料袋中，然后放进钢制容器。首选的反应是离开该区域，让电池冷却，蒸汽消散，避免皮肤和眼睛接触或吸入蒸汽。

Steps to be Taken in case Material is Released or Spilled

If the battery material is released, remove personnel from area until fumes dissipate. Provide maximum ventilation to clear out hazardous gases. Wipe it up with a cloth, and dispose of it in a plastic bag and put into a steel can. The preferred response is to leave the area and allow the battery to cool and vapors to dissipate. Avoid skin and eye contact or inhalation of vapors.

废弃物处置方法

建议将电池完全放电，消耗电池内部的锂金属，盐水浸泡处理后，交给专业的回收公司处理；或按照当地法规处理。

Waste Disposal Method

It is recommended to discharge the battery to the end, to use up the metal lithium inside the battery, immerse in salt water, and then give it to a professional recycling company for processing; or handle in accordance with local regulations.



7. 操作处置和储存 Handling and storage

禁止打开、毁坏或焚烧电池，因为电池有可能在这些处理过程中发生爆炸、破裂或泄露等事故。禁止将电池短路、过充、强制放电或扔入火中。禁止挤压刺穿电池或将电池浸入溶液中。

The battery should not be opened, destroyed or incinerate, since they may leak or rupture and release to the environment the ingredients that they contain in the hermetically sealed container. Do not short circuit terminals, or over charge the battery, forced over-discharge, throw to fire. Do not crush or puncture the battery, or immerse in liquids.

操作处置和储存中的防范措施

禁止物理或电滥用，禁止高温储存，最好将电池储存在阴凉、干燥、通风等温度变化较小的环境中。禁止将电池接触加热设备或将电池直接暴露与阳光中。

Precautions to be taken in handling and storing

Avoid mechanical or electrical abuse. Storage preferably in cool, dry and ventilated area, which is subject to little temperature change. Storage at high temperatures should be avoided. Do not place the battery near heating equipment, nor expose to direct sunlight for long periods.

Other Precautions

The battery may explode or cause burns, if disassembled, crushed or exposed to fire or high temperatures. Do not short or install with incorrect polarity.

In case of battery venting, provide as much ventilation as possible. Avoid confined areas with venting cell cores.

Respiratory Protection is not necessary under conditions of normal use.
